





# Mission

The Images for Conservation Fund (ICF) fosters conservation of wildlife through sustainable development using the power of nature photography while integrating art, education and natural history.

# **Sustainable Development**

ICF is committed to sustainable development of rural economies through the creation and prosperity of the Nature Photo Tourism Industry. The Pro-Tour and Legacy competitions are the catalyst for galvanizing nature photographers into a dynamic industry. The growth of the industry will vastly expand opportunities for photographers and will generate significant financial returns for communities, businesses and landowners who embrace this new industry and conserve wildlife habitat.

# Wildlife Conservation

Eighty percent (80%) of North America's land is privately owned. ICF's photo competitions, programs and economic incentives encourage private landowners to restore, preserve, and enhance wildlife habitat. When society views wildlife as a valuable economic resource, landowners will work diligently to preserve wildlife habitat.

# **Education**

ICF instructs private landowners about how they may benefit from their land's wildlife through photography, including how to create and market ideal photographic settings on their land, and teaches nature photographers about the advantages of photographing on private land. ICF also utilizes professional photographers and private lands to provide educational opportunities for children and adults to cultivate a greater appreciation for nature through photography.

# <u>Art</u>

ICF promotes photography as a visual voice for nature. Photography offers an artistic medium to communicate the beauty and mystery of nature through the individual imagination of the creative nature photographer. Images from ICF nature photo competitions will be featured in books and exhibitions for the public's education and enjoyment.

# Natural History

ICF promotes the study of plants, animals and ecology through the imagery of professional and amateur nature photographers. Images from ICF's nature photo competitions will help to chronicle the biodiversity of North America.



# **Executive Summary**

In the past 30 years, the world's major wildlife conservation organizations have discovered that people living with wildlife must have an economic stake in preserving it. "Sustainable development" programs, especially business enterprises that associate wildlife with income benefits for the local people, are now successfully protecting wildlife habitats in developing nations. The **Images for Conservation Fund (ICF)** believes that sustainable economics for conservation are equally important for the biodiverse regions of North America.

Conservation must become more efficient from now on, and resources must be leveraged to their maximum effectiveness. As human populations increase, and countries become more affluent, the costs of protecting individual preserves or entire ecosystems through land purchase has become prohibitive. ICF can leverage the protection of more habitats for an investment of far less dollars. Nature photography offers the perfect method for generating sustainable income to protect biodiversity and benefit rural communities.

## The Nature Photo Tourism Industry is the most cost-efficient method to conserve wildlife habitat:

- For example: the Texas Hill Country is approximately 20,000 square miles, nearly 13,000,000 acres.
- To protect 10% of this land through purchase would cost \$2,600,000,000 (1,300,000 acres x \$2,000 per acre), with additional costs of annual management and maintenance
- The economics of the nature photo tourism industry will make wildlife valuable to landowners. This will protect habitat and lead landowners to restore, protect, and improve the lands wildlife habitat.
- All types of wildlife and habitats will become economically valuable and "worth preserving." Revenue potential is <u>directly</u> tied to the prosperity and diversity of the land's wildlife.
- The industry also will create jobs: i.e. photographic site design and construction, guide services, etc.
- Rural communities (hotels, restaurants, etc.) will benefit from increased tourism

ICF has developed several catalysts to stimulate the growth of this new conservation industry:

**The Pro-Tour of Nature Photography** is ICF's flagship event, the world's first all-professional nature photo tournament. Photographers and landowners are paired into teams to promote conservation, create outstanding natural images and promote the nature photo tourism industry on the most beautiful and biodiverse lands of North America. The **Inaugural Event** will be held in the **Texas Hill Country in April 2006**.

**Legacy Competitions** are planned for each Pro-Tour destination. These tournaments are open to all landowners and photographers and will perpetuate the development and promotion of conservation.

**Photo Books & Museum Exhibits** will share winning images of nature with people of all ages and create long-term, widespread exposure for Pro-Tour Sponsors.

**The Nature Photo Tourism Industry** is the tool for the future of conservation. It leverages existing ownership of habitat through the cooperative spirit of photographers, landowners, conservation groups, corporate America, and the general public: to work together for the long-term preservation of nature. # The Valley Land Fund's Wildlife Photo Contest

# OUR SUCCESSFUL PROTOTYPE

In 1987, John Martin, Tom Koeneke, Carol Rausch and other concerned citizens of south Texas created **The Valley Land Fund (VLF)**, a non-profit organization dedicated to preserving the remaining wildlife habitat of the Rio Grande Valley. To accomplish this goal, VLF has used all the tools common to land trusts (conservation easements, etc.).

What distinguishes VLF is the use of wildlife photo competitions for fundraising, conservation and public awareness. Since 1994, The Valley Land Fund Wildlife Photo Contest has introduced hundreds of south Texas ranchers to the beauty and value of their land's wildlife, and it has inspired a generation of amateur and professional photographers to push their talents to the limit.

Each of the VLF Contests has featured an Awards Ceremony gala and commemorative coffee table book with award-winning images. It has become a local tradition in habitat conservation, artistry and education, involving photographers of all ages and skill levels. It also has become the prototype for the **Images for Conservation Fund (ICF)** and the world's first Pro-Tour of Nature Photography. In fact VLF founders John Martin, Tom Koeneke, Carol Rausch are also founders of ICF.

Most importantly, the VLF Wildlife Photo Contest has inspired the nature photo tourism industry in south Texas. Landowners have discovered a valuable new source of revenue by constructing professionally planned photographic settings and day-leasing their use to wildlife photographers. So far, eight Texas ranches, representing 15,000 acres, are part of a pilot program called **South Texas Lens & Land**. With very little publicity in their first years, these ranches have attracted photographers from around the world who are eager to experience the exceptional convenience and photographic opportunities offered by these Texas ranches.

Images for Conservation Fund combines these ideas into a full-fledged industry using competitions as primary marketing tools. This concept, born in south Texas, is a model for conservation through sustainable economics, and the essence of ICF's Mission.



# **Structure for the New Industry**

We are modeling the Nature Photo Tourism Industry after the Professional Golfers Association and the highly successful, \$62 billion Golf Industry. As with golf, the pinnacle event (The ICF Pro-Tour) involves only a few people but inspires many people to compete (Legacy Competitions) and many more to participate recreationally (Photo Industry).





# **Conservation Through Leverage**

Purchasing land for conservation is the least cost-efficient method of protecting habitat. Conservation can be best achieved by leveraging existing land ownership through the development of sustainable economic incentives. Nature photography offers the most economic benefit to private landowners with the least impact on wildlife species.

The Initial Goal<sup>1</sup> for the Hill Country is to attract 0.8% of the 2,500,000<sup>2</sup> serious wildlife photographers, approximately 20,000 annually.

**The Initial Goal**<sup>1</sup> **for Texas** is to attract 4% of the 2,500,000<sup>2</sup> serious wildlife photographers, approximately 100,000 annually.

The following table shows the economic benefit to the Hill Country and Texas.

#### **EXAMPLE: 500 Acres of Great Wildlife Habitat**

#### LAND PURCHASE

- \$1,000,000 would require be raised in order to protect the same habitat through purchase this same tract of habitat.
- \$100,000 would be required annually to maintain and protect the property.

# SUSTAINABLE ECONOMIC INCENTIVES

- Host 10 photographers per day at \$100 for 200 days a year brings \$200,000 of new income per year. The habitat would be protected because of sustainable economic incentives.
- Habitat protection concurrently provides jobs and economic benefits to rural communities.

ICF and the Nature Photo Tourism Industry represent the most efficient economic tools for conservation because they leverage the existing ownership.

Based on survey estimates by the U.S. Fish & Wildlife Service, there are: 26,000,000 Americans who photograph wildlife, and 2,500,000 are Serious Wildlife Photographers, Americans who photograph wildlife for 10 days or more each year.



# **Pro-Tour Events**

Kickoff Event March 18, 2006

- The Trade Show will be focused on the corporations and organizations that provide products and services to photographers and landowners. Participating companies will include photographic equipment suppliers; computer and peripheral equipment suppliers; travel and tourism service companies; federal, state and NGO organizations that provide small business and management aid and services; and private land management consulting firms.
- The Symposium will be a dual-track event intended to provide educational opportunities for photographers and landowners. The Photographer Track will focus on issues pertinent to nature photographers. Topics will include wildlife photography basics; advanced techniques; species identification; digital imaging; and computer use for image processing, archiving, display and printing. The Landowner Track will focus on the issues pertinent to landowners who want to create eco-tourism businesses based in nature photography. Topics will include: establishing an eco-tourism business; building photo-blinds and settings; habitat management for biodiversity; federal, state and NGO landowner assistance; and computer essentials for landowners.
- The Matching Dinner is a high-profile fundraising event during which the 20 landowners will be randomly matched with the 20 professional photographers. For public interest, each of the participants will be introduced in a multimedia format that will highlight their work and accomplishments.

#### **The Pro-Tour Competition Period**

April 1-30, 2006

During this time the photographers will be on their teammates' ranches actively photographing and creating their portfolio of images. Each team's portfolio will feature 75 images, with 15 images from each of the Pro-Tour Categories: Birds, Mammals, Reptiles & Amphibians, Insects & Arachnids, and Plants & Landscapes.

#### The Awards Ceremony

**June 2006** 

This is the Pro-Tour's climax event. The winning photographer-landowner teams will be announced, and prize money will be awarded. This will be a visually spectacular multimedia event, featuring photographs from each of the winning teams using an array of photography-related products and technology.

Traveling Exhibits June 2006

Traveling exhibits will be created to feature the outstanding images from the 2006 Pro-Tour. These museum quality exhibits can be displayed in various venues such as: museums, art exhibits, industry trade shows and sponsors' lobbies.

#### The Commemorative Coffee Table Book

November 2006

A deluxe, full-color hardback book will be published to highlight the images, photographers, landowners and sponsors of the 2006 Pro-Tour. These books will be sold to hundreds of individuals and businesses, and donated to local schools.

#### The Book Dedication Party

November 2006

This will be a fundraising event celebrating a major local figure in wildlife habitat conservation.



# PHOTOGRAPHY'S NEW PRO TOUR

A high-dollar photo contest hopes to promote the idea of "photography leases" as a new revenue stream for landowners.


Landowners with at least 500 acres of wildlife habitat in any of 19 counties in the Texas Hill Country are eligible to participate in the inaugural Pro Tour of Nature Photography. The event, scheduled for April 2006, will pair 20 renowned nature photographers with 20 private landowners in the Texas Hill Country to compete for a share of up to \$200,000 in cash. The application deadline is April 1, 2005, and landowner participants will be announced May 1.


"This is the first all-professional tournament of nature photography in the world," says John F. Martin, who founded Images for Conservation Fund to produce the event. "We created ICF and the Pro Tour for Nature Photography to foster nature-photography tourism as a long-term income producer for private landowners, rural economies and nature photographers to help protect the wildlife of North America. Conservation and enhancement of wildlife habitat is the ultimate objective of the Pro Tour."

Martin, who lives near Edinburg, Texas, is a longtime conservationist and co-founder of the Valley Land Fund, a Rio Grande Valley land trust that has produced a biennial wildlife photo contest since 1994.

The contest is limited to landowners in the following counties: Bandera, Bexar, Blanco, Burnet, Comal, Edwards,

Landowners and photographers will be randomly matched into teams. Each photographer-landowner team will submit a 75-image portfolio to be judged by Rosamund Kidman Cox, longtime editor of BBC Wildlife magazine; Stephen B. Freligh, publisher and editor-in-chief of Nature's Best magazine; and world-famous nature photographer





Art Wolfe. Winning portfolios will win glassy cash awards and be featured in a glossy coffee-table book and an exhibit that will travel to museums and major sponsors' locations.

According to the U.S. Fish & Wildlife Service and the Photo Marketing Association International, there are approximately 26 million Americans who photograph wildlife every year. "Through the Pro Tour of Photography, Images for Conservation Fund intends to help create a booming industry where private landowners lease top-quality wildlife photo settings on their land for a significant new stream of income," Martin says. "Lack of ways to create of income from land ownership is one of the major reasons family lands are being \( \frac{N}{2} \) subdivided and sold, which in turn is the  $\stackrel{\text{\tiny T}}{\bowtie}$ primary reason for habitat destruction."

# **Landowner & Youth Education Programs**

## Introduction

The ICF Education Program presents a solid base for introducing landowners, youth and public to the benefits of nature photography and its ability to create sustainable economics for wildlife conservation.

# **Private Landowner Education**

Many private landowners are knowledgeable about the needs of hunters, such as elevated blinds to see long distances and game feeders to attract the animals, but they have little understanding of what nature photographers need for creating great images and having a rewarding photographic experience.

ICF has created its Landowner Education program using pro photographers to educate Pro-Tour landowners on leasing to photographers. Seminars and ranch visits will be held both before and after each Pro-Tour competition. Once the Pro-Tour landowners understand these specialized needs, each of the 20 landowner-photographer teams will work together in a spirit of cooperation, learning from one another, and working toward a common goal of winning the competition. By the end of the Pro-Tour, these landowners will be well prepared to day-lease their lands to amateur and professional photographers in the Nature Photo Tourism Industry.

# **Youth Education**

The Nature Photo Tourism Industry is vital to wildlife conservation on private lands. ICF is working to ensure the future of the industry by teaching young people and their instructors the enjoyment and education that comes from nature photography. We will do this in collaboration with one or more national youth organizations.

# **Texas Hill Country Book**

To commemorate each Pro-Tour competition, ICF will create a coffee table book featuring the event's most outstanding images. The book also will feature a written introduction to the images of the region's plants, animals and landscapes, plus in-depth information about nature photography and its importance to understanding biodiversity. There will be 5,000 - 10,000 copies sold and distributed throughout the region and beyond. The books will be offered to schools throughout the region as an important tool for learning about ecology and biology. We would like also to create a curriculum guide to help teachers use the book. Through the books, our goal is to have an important impact on at least 10,000 students per year.
